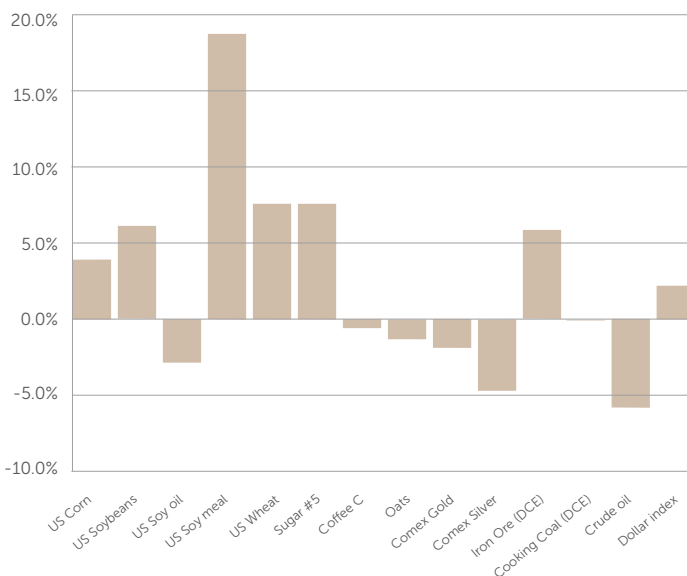
INVESTMENT OBJECTIVE

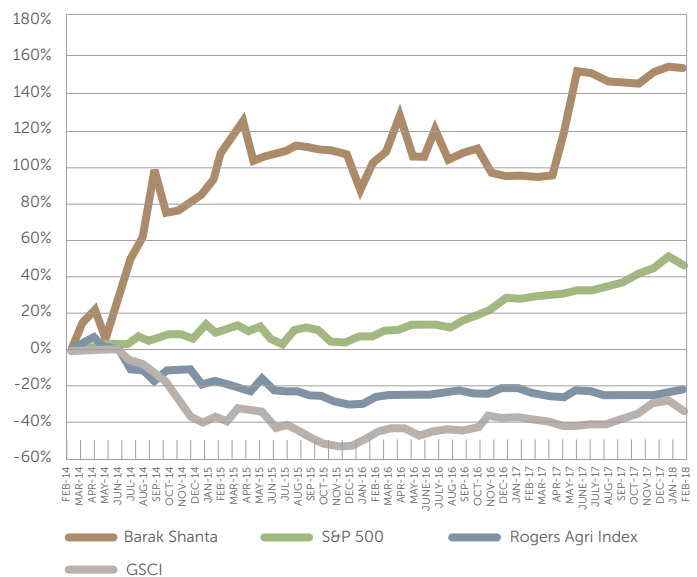
